# Purpose and Terms and Conditions of the Transport Credit Agreement for Parcel Services

By this Agreement, Oy Matkahuolto Ab (hereinafter "Matkahuolto") and the Company agree on the use of the transport credit extended by Matkahuolto.

The payments for the credit used under this Agreement include all payments charged by Matkahuolto for transport services, such as carriage, storage, documents, pick-up, distribution, etc.

However, the Agreement does not apply to payments for incoming cash-on-delivery consignments.

## **Transport credit service charge**

Use of the transport credit is subject to a service charge in accordance with the then-current price list. At the time of signing of this Agreement, the service charge is EUR 14.75 per month (VAT 0%). No service charge is payable if no credit has been used and no invoice generated.

## **Terms of payment**

The charges made for the services hereunder are invoiced to the debtor. The invoices fall due for payment on the due dates indicated in them. Any past-due payments are subject to a penalty interest at the ten-current rate, which is 16% at the time of signing of this Agreement.

The payment time is 14 days net.

## **Term of the Agreement and termination**

This Agreement is valid for an indefinite period of time subject to one month's notice. Any notice of termination must be given in writing.

## **Additional terms and conditions**

Transports will be governed by the Finnish Road Transport Agreements Act and Matkahuolto's General Conditions for Carriage of Goods. The only acceptable shipping documents are those specifically approved by Matkahuolto. Additional information is provided at [matkahuolto.fi](http://matkahuolto.fi).

To be eligible for credit, the Company is required to submit to Matkahuolto a valid extract from the Trade Register.

All deliveries invoiced under this Agreement must be made in the name of the Company or other name specified herein.

The copies of the shipping documents due to the Company will be released when consignments are dispatched or claimed unless otherwise agreed in writing. A special charge will be made for any additional copies of shipping documents requested by the Company.

Matkahuolto must be informed in writing of any changes to the Company's name, legal form or contact persons, and an extract from the Trade Register issued after such changes is to be provided.

Matkahuolto must be informed of any change of address. If the invoice is delayed because of a failure to file the required notices, the invoice will nevertheless fall due on the specified due date.

If any invoice is not paid by the due date, credit will be suspended or stopped and any related additional agreements terminated with immediate effect. Matkahuolto has the right to offset any amounts due against any payables to the debtor and/or seize consignments owned by the Company as security for payment without consulting the Company.

Additional agreements may be made for inclusion in this Agreement as annexes subject to the terms and conditions of this Agreement as applicable.
